

**FACTS** **What do First Republic Bank and its affiliates do with your personal information?**

**Why?** Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?** The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- » Social Security number
- » Account balances
- » Transaction history
- » Credit history
- » Assets and investment experience

**How?** All financial companies need to share clients' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their clients' personal information; the reasons First Republic chooses to share; and whether you can limit this sharing.

## What we do

How does First Republic protect my personal information?	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>We conduct periodic reviews of our computer systems, including security features. Additionally, our employees are required to acknowledge their responsibility to maintain the confidentiality of Customer Information.</p>
How does First Republic collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>» Open an account or apply for a loan</li> <li>» Make deposits or withdrawals from your account</li> <li>» Enter into an investment advisory contract</li> <li>» Seek advice about your investments</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>» Sharing information about your creditworthiness with affiliates for everyday business purposes</li> <li>» Affiliates from using your information to market to you</li> <li>» Sharing for nonaffiliates to market to you (<i>First Republic does not do this.</i>)</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. <b>See the "Other important information" section below for additional rights provided under state law.</b></p>
What happens when I limit sharing for an account I hold jointly with someone else?	Each account holder must opt out individually.

Affiliates	<p>Companies related by common ownership or control.</p> <ul style="list-style-type: none"> <li>» Our affiliates are: First Republic Bank and its First Republic Trust Company division; First Republic Trust Company of Delaware LLC; First Republic Securities Company, LLC; First Republic Securities Company, LLC DBA Grand Eagle Insurance Services, LLC; and First Republic Investment Management, Inc.</li> </ul>
Nonaffiliates	<p>Companies not related by common ownership or control.</p> <ul style="list-style-type: none"> <li>» First Republic does not share with nonaffiliates so they can market to you.</li> </ul>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>» First Republic doesn't engage in joint marketing.</li> </ul>

## Other important information

California and Vermont laws place additional limits on sharing information with our affiliates about residents of those states.

**For California:** In accordance with Division 1.4 of the California Financial Code, the Company shares information we collect with affiliates when a client consents to such sharing or the information is released in connection with a written agreement between the client and First Republic Securities Company or First Republic Investment Management for the sole purpose of providing products or services covered by such written agreement. For clients with a California mailing address, we will not share information with affiliates when clients are given notice and opportunity to opt out and direct us not to share.

**For Vermont:** We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
